# Chiesi commits to become net zero by 2035

90%



## Our emissions reduction plan invites accountability

Our net zero objective is based on the first global, science-based standard for companies to set net zero target, as developed by the Science Based Targets initiative (SBTi).

Our commitment to disclose our emissions inventory yearly will allow us benchmark Chiesi's performance against that of industry peers on a regular basis. Our reduction targets have been approved by the Science Based Target Initiative (SBTi) and are in line with the Paris Agreement's most ambitious goal to limit global temperature rise to 1.5°C above pre-industrial levels by 2100.



Our emissions are identified and measured according to the Greenhouse Gas Emissions (GHG) Protocol.
